Topic 2: The Erasmus Programme at the University of Rome Tor Vergata

Prof. Cinthia Campi presented how the University of Rome Tor Vergata manages and develops the projects within the Erasmus+ Programme, also focusing on the services provided to students and teachers.

Topic 3: The Education System – Engineering Universities at the Universities of Rome

Prof. Stefano Giordani presented the Engineering Education System at the Universities of Rome Tor Vergata. He paid special attention to the Learning Pathways, Class Schedule and Engineering Degree Programs.

Prof. Luca Persia presented the Engineering Education System at the Sapienza University of Rome.

Prof. Antonio Comi presented

Subsequently, he outlined SmaLog Project, including SmaLog aims. Special attention was paid to relationships among WGs and WPs, allocation of responsibilities concerning to WG and WP and flows of responsibilities. The main future tasks for all participants of the project was identified.

Action 1: all partners were asked to inform coordinator of main staff involved in SmaLog as well as changes in contact details of each involved partner to be also sent Project Officer **Action 2**: overview of allocation of responsibilities in each task as in the original application

Topic 6: Administrative, financial and operational aspects

The content of main components of Grant Agreement was presented by Prof. Antonio Comi. Prof. Antonio Comi presented the structure and content of Partnership Agreement. The structure of payment was discussed and agreed. Besides, according to the suggestions received from Project Officer, the way for reimbursing the host institution for each meeting was also agreed:

the host organises coffee breaks and lunches, and some dinners. The coordinator gets the whole bill and reimburses the host from Erasmus+ budget as follows: the coordinator divides the whole bill to each participating person (corresponding to their attendance) and reduce the reimbursement of costs of stay accordingly. It is preferable that participating persons will be informed in advances on this way of proceeding.

It was decided to sign a single agreement between all partners (Multilateral Agreement).

Prof. Antonio Comi presented the content of Grant Agreement for student's mobility under SMS and Grant Agreement for staff mobility under SMS.

Prof. Antonio Comi introduced the structure of Technical and Financial reporting. Attention was paid to the study of the financial rules for the management of the Grant and the examples of financial report. The structure of payment arrangements was agreed.

Prof. Antonio Comi introduced rules for WP 9 - Dissemination & exploitation of results.

Topic 8: The Higher Education System

The Ukraine Higher Education System – Technical and Economic Universities

Associate professor Dmytro Roslavtsev told about:

- Higher Education system in Ukraine;
- Implementation of the Master's programme in SmaLog taking the requirements of the Specialty Standard into account;
- Internal Quality Assurance System and prospects for its development in O. M. Beketov National University of Urban Economy in Kharkiv.

The Georgian Higher Education System – Technical and Economic Universities

Mrs. Teona Dzneladze and Prof. Roman Mamuladze introduced MET in Georgia, in the directions:

- The features of Maritime Education and Certification;
- Qualification Frame;
- Qualification Frame Business and Management.

Prof. Dr. Giorge Doborjginidze presented Georgian Educational System, Engineering Degrees and Accreditation Procedures, in the directions:

- Georgian Educational System;
- Qualification Framework for Transport and Logistics Programs;
- Experience of Double Degree Requirements Based on the Bologna Criteria.

The EU Higher Education System and Erasmus+/Tempus experiences in Poland and Germany

Prof. Aleksander Sładkowski told about:

- Structure of education system and Structure of higher education in Poland (from September 2017);
- Educational process at the Faculty of Transport of SUT (full-time education);
- Tempus experiences.

Prof. Dr.-Ing. Manfred Ahn presented the questions:

- European Higher Education Area (EHEA) and Bologna process;
- The Qualifications framework;
- Tempus experiences.

Topic 9: Discussion: differences in the Educational path to getting the Master degree, Possibility of Double Diploma realization

After detailed familiarization with the specific of Education Systems in Universities of Italy, Poland, Germany, Ukrainian and Georgian participating in SmaLog, the differences in the educational path to getting the Master (of Specialization and Science) degree have been recalled

starting from investigation carried out during application design and submission. The partners agreed to update the info collected before and to check again the opportunity for the Georgian and Ukrainian contexts to implement Master of Specialization according to their new incoming needs and academic regulations. This situation can effect on a Possibility of Double/Joint Diploma realization. It was decided to elaborate on the Possibility of Double/Joint Diploma realization and have a consultation with the EACEA Erasmus+ office in Brussels during the first meeting of new funded project in January 2018, and Ministry of Education in all countries, which participate in the project, in order to define what is best for partner countries and how to proceed if arrangements have to be asked. Besides, the coordinator explores the constraints present in each involved partner institutions in order to present a whole overview to the Project Officer in Brussels.

Topic 10: Description of Working Groups and allocation of responsibilities

WG1 - SmaLog Master Programme preparation and development

Prof. Oleksii Lobashov introduced WG1 (SmaLog Master Programme preparation and development) and Work Packages related to this WG: WP2, WP3, WP4, WP6. According to the detailed description of the project the objectives of each Work Package and key role of WG1 were presented. Master Programme preparation and development consists of subgroups: WG1/passenger - Passenger Transportation, WG1/freight - Freight Transportation, WG1/traffic - Traffic Flows, WG1/smart - Smart Transport, Industry sector.

In the WP2, the draft version of Curriculum (Module), taking into account the distribution of Universities and modules into target groups, was presented.

Also Prof. Oleksii Lobashov considered all the activities, travels and expected outputs regarding to each Work package in WG1.

WG2 - Improvement of study infrastructures at Partner Country Universities, including dissemination and exploitation

Mr. Vasyl Mamray as a leader of WG2 introduced the objectives and the Work Packages which include in this group: WP5 and WP9. Planned travels and their terms was presented. According to Description of the project the expected outputs were formulated. He was asked to start the revision of equipment list in order to be ready for submission to EACEA for final approval before starting purchasing.

WG3 – Development of International Quality Assurance System

Dr. Minakova Svitlana as a representative of the leader Institute of WG3 introduced the objectives and the following Work Packages related to this group: WP7 and WP8. Planned travels and their terms were presented. According to Description of the project the expected outputs were formulated.

Topic 11: Description of Working packages

WP2: EU-UA-GE Joint Master Programme in SmaLog

Dr. Aleksander Sładkowski as leader of WP2, according to detailed description of the project, presented the main tasks, responsibilities and leaders in accordance with each activity (planned terms) and target group were presented. He proposed as first visit of WG1 representative (according to the original application) in the week 19-23rd of March 2018, in Katowice. The others to be hold in Rome and in Wismar will be defined in the next weeks taking into consideration the needs of SmaLog and partners involved.

Action 9: definition of dates of next meetings in Rome and Wismar

WP3: Theoretical fundamentals of PhD Programme in SmaLog

Dr. Andrea Campagna introduced the objectives, task and approach of the WP3. Logical block diagram of the approach was created and presented for greater understanding the structure of WP3. Planning outputs, terms of activities and roles and responsibilities were presented.

WP4: System of UA & GE University SmaLog teachers' skills upgrading

Prof. Olha Kunytska introduced the objectives of the WP4. Content of each activity, their terms, expected outputs and allocation of responsibilities according to detailed description of the project were presented.

WP5: Methodical, organizational and technical support of SmaLog students' training

Mr. Vasyl Mamray introduced the objectives of the WP5. Content of each activity, their terms, expected outputs and allocation of responsibilities according to detailed description of the project were presented.

Discussion: According to WP5.3 "Project web-site, Facebook Page/Group", the Project web-site language was discussed.

It was agreed that:

- GE Universities (coordinated by GTU) use English language and for info that could not be easily accessible to audiences will be also translated in Georgian;
- UA Universities (coordinated by ZSTU) use English and Ukrainian languages.

Action 10: Georgian partners will be responsible for Georgian language of the project websites Action 11: Ukrainian partners will be responsible for Ukrainian language of the project websites

WP6: Pilot SmaLog students' training

Prof. Oleksii Lobashov presented objectives and main contents of activities of WP6, their duration, expected outputs and allocation responsibilities according to detailed description of the project. Special attention was paid to Curriculum, its duration and contain.

Discussion: According to WP6, the Curriculum and Modules were discussed. Do they have to be the same for UA&GE universities?

It was considered the possibility of anticipating the enrolment date of 1st semester from January 2019 (as in the original application) to September 2018 (as new year academic year), because of:

• the main aim of the project is to graduate students during the project time implementation;

• educational year in UA&GE universities starts in September.

Representatives of GE universities introduced the problem of SmaLog implementation in September 2018, because the need of the new Master Programme accreditation. The duration of accreditation procedure is 1 year.

It was agreed that:

- Representatives of GE universities have to identify their possibility to implement SmaLog in September 2018; to present the suggestions on the next meeting, which are devoted to WP2;
- The omission in the WP.6.5 "Teachers' exchange between UA and GE Universities" was found, this activity was not include in the Budget of the project. PMC should consider the eventual possibility of the redistribution of the budget before to implement such an action.

Action 12: Local universities investigate possibility to anticipate enrolment of students

WP7: International Quality Assurance System

Prof. Umberto Crisalli presented objectives and main activities of WP7, their duration, expected outputs and allocation of responsibilities according to detailed description of the project.

WP8: Project Quality Control and Monitoring

Dr. Minakova Svitlana presented objectives and main activities of WP8, their duration, expected outputs and allocation responsibilities according to detailed description of the project. Associated Partners and their role in the project were presented.

WP9: Dissemination and Exploitation activities of the project

Prof. Mykola Zhuk presented objectives and main activities of WP9, their duration, expected outputs and allocation responsibilities according to detailed description of the project.

Discussion: All participants of the Meeting voted the project LOGO through the anonymous voting among the more voted during a first online selection.

It was agreed

- in the nearest time after the meeting each partner places the Logo with the link on the website of the project on the Universities' sites, remembering that the priority in visibility must be given to Erasmus+ logo;
- Prof. Mykola Zhuk asks each partner useful info to publish in the website according to a form that will be soon shared;
- Social profiles (e.g. facebook, twitter) will be created and shared among potential users of SmaLog.

Action 13: to post information about the SmaLog team on the project website

Action 14: to create and update the project Facebook and Twitter pages

Action 15: to add the link to the official project web-site to the Universities web-pages devoted to the project

Action 16: to post information about the open days on the project website

WP10: Management activities of the project;

The coordinator, Prof. Antonio Comi presented objectives and main activities of WP10, their duration, expected outputs and allocation of responsibilities according to detailed description of the project.

According to WP10.1 Contractual issues and Project Progress Reports the issues related with the equipment purchasing were noticed: a **tendering procedure** is required by EACEA rules if the value is over € 25.000 and less than €134.000 and the beneficiaries may not split the purchase of equipment into smaller contracts

Special attention was paid to communication between partners and given timely responses to messages for smooth Project realization. It was notice, that a quick look to a document could often avoid major problems later.

According to the first meeting for new funded Project in Brussels, it was agreed that coordinator will contact the EACEA for asking that two representatives of partner countries, one from Ukraine and one from Georgia, can join coordinator.

It was asked to coordinator to verify again with Project Officer if the expenses due to hospitality (e.g. coffee break, quick lunches, networking dinners) can shared among participants according to their attendances using the costs of stay.

Action 17: investigation on the procedures for purchasing equipment

Action 18: to ask EACEA the possibility two representatives of partners countries can attend the meeting in Brussels

Action 19: to ask Project Officer if hospitality expenses can be shared among partners using costs of stay.

Action 20: merging of possible travels and provide an overview of travels along SmaLog.

Action 21: NUUE and UNITOV will prepare the minutes of meeting that will be upload on the website.

Topic 12: Special Mobility Strand (SMS)

Prof. Kateryna Vakulenko presented objectives and main activities of SMS, their duration, expected outputs and allocation responsibilities according to detailed description of the project. The importance to plan in advance such visits in order to be ready with all agreement to be signed before travels.

Discussion:

It was deepened the opportunity to define clearly the objectives of this mobility taken into consideration the duration the Studying and Traineeship period for students and the tasks that will be performed the students in this period. The financials aspects according to SMS were also focused remembering that partners have to co-funded some activities as detailed in the guidelines of the projects funded in the call 2016 and agreed during SmaLog submission.
