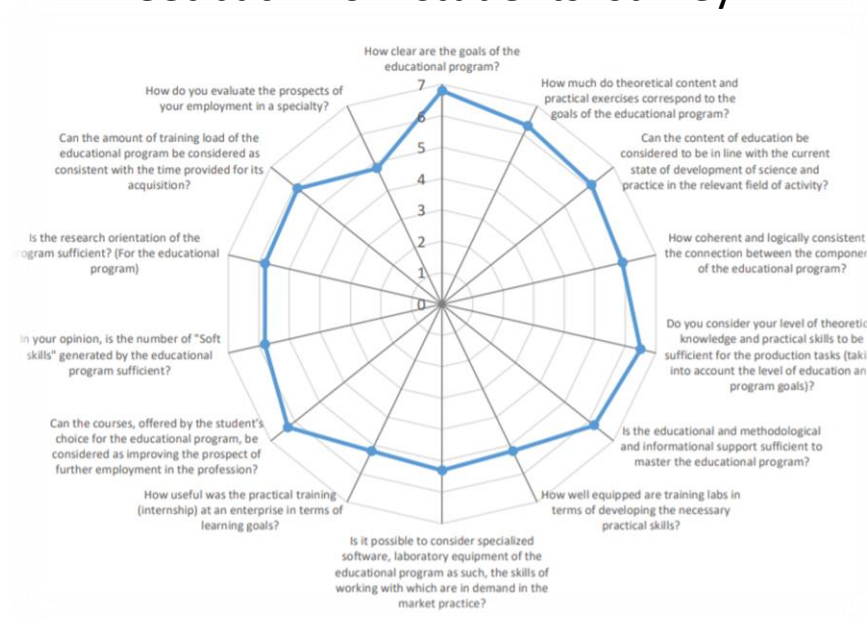
Feedback provided by peers, employers, stakeholders (including EU representatives), students and staff via employability of alumni indicators, student academic performance.

# Identified issues and proposal for going ahead



Identified weaknesses:

1. Total number of student does not meet to planned number of students (90 to 72 resp.).
2. WP 6.5 Teachers' exchange between UA and GE Universities is not implemented. Reason: it is not planned budget for this activity.
3. % of the new curriculum taught in foreign language of the total of new curriculum developed by the project does not meet to specified in Application (100 % to 23 % resp.)
4. Volume (in ECTS) of new/updated courses does not meet to specified in Application (100 to 60 resp.)
5. It was planned, but it is not implemented: Master degree in SmaLog (it will be graduated by two diplomas (e.g. Ukrainian /Georgian) and Double/ degrees among Partner and Programme countries' institutions). Joint/double degree was postponed, as agreed/shared with Project Officer.
6. Only separate modules of SmaLog introduced in ZSTU, GTU, BSMA.
7. GTU and BSMA are not shared their information regarding teaching process at their universities.

# Identified issues and proposal for going ahead



Proposal for going ahead:

1. Accredite Smalog program by the National Agency for Higher Education Quality Assurance (Ukraine) in NTU, LPNU.
2. Totally implement in ZSTU with further accreditation by NAHEQA (Ukraine).
3. Implement educational program Smalog in Georgian universities GTU, BSMA.
4. Improve SmaLog Curricula (content, training process) namely based on feedbacks.
5. Implementation Guide of QAS developed in framework of the project at universities.
6. Develop KA1 project for Smalog students and staff.
